#### **ANIMAL PER DIEM RATES**

*Per diem* is defined as the expenses required to maintain an animal or cage of mice for any portion of a calendar day. Per diem charges start accruing upon arrival at our facilities.

Animal *per diem* rates are calculated using the Cost Analysis and Rate Setting Manual for Animal Research Facilities, № 00-2006 rev. May 2000 developed and published by the National Center for Research Resources (NCRR) at the National Institutes for Health (NIH).

For budgeting purposes, Principal Investigators should assume a 5% increase on July 1 for each fiscal year.

The listed rates include standard husbandry practices utilizing standard personal protective equipment (PPE), housing type, and biosafety level. Rates for projects requiring additional services (for example strict barrier housing, quarantine, diagnostic laboratory testing, non-standard PPE) may differ significantly and will be charged in addition to standard per *diem rates*. In these cases, it is highly recommended that the user consult with Animal Resources in order to establish a budget.

Rates are subject to review and revision in January and July of each year.
